

Terms and Conditions

1. ****It is the buyer's responsibility to review and judge vehicle conditions before bidding.****
2. The auction end date and time may be changed without notice to the bidders, please check back often.
3. To allow bidders plenty of time to bid, auction times will be extended if there is bidding activity in the last few minutes
4. All bidders must register before each sale. Bidding on any vehicle is confirmation of acceptance of all these Terms and Conditions.
5. The sales sheet/run list may change at any time. Bidders rely solely on their own observations and inspections in determining whether to buy a vehicle.
6. Payment for vehicles must be in cash, or certified check.
7. AUCTION HOURS 9:30 AM TO 4 PM ON THURSDAY, FRIDAY AND MONDAY FOLLOWING THE AUCTION. ANY PICKUPS AFTER NORMAL PICKUP TIMES MUST BE BY APPT AND SOLEY UP TO AUCTION STAFF WHEN AVAIL.
8. ****Vehicles must be paid and removed 48 hours after the sale.** No pickups after 4pm or on Saturday or Sunday. ********
9. Failure to pay and pickup by the Friday following the auction will result in 25.00 per day storage. You Must notify the office if you are unable to pick up on time. You must contact the staff no later than that following Monday by 12pm.
10. The auction is not responsible for loss or damage to vehicles that are not immediately paid for and removed from the property.
11. The A-1 Towing Service Auction hereby disclaims and excludes any and all warranties of title, including without limitation that the title is good and its transfer is rightful, and that the vehicle is delivered free from any security interest or other lien or encumbrance. The Auction also disclaims and excludes any and all warranties that the vehicle is delivered free from any rightful claim of any third party by way of infringement or the like. All vehicles are sold "AS IS WITH ALL FAULTS", including but not limited to dash lights and mechanical defects. This is a police impound lot, we do not know the full history of the vehicle. The Auction hereby disclaims and excludes any and all implied warranties, including without limitation the implied warranties of merchantability and fitness for a particular purpose.
12. The sole and exclusive remedy for breach of contract of warranty shall be the return of the vehicle and repayment of the purchase price. Under no circumstance shall A-1 Towing Service Auction be liable for consequential or incidental damage; including but not limited to repairs, improvements, loss of use, and DMV/Registration fees.
13. All vehicles will be assessed a buyer fee, see the website for details
14. All vehicles must be towed out by your own tow company or for an additional fee arrangements can be made with A1 Towing.
15. All bids stand. A1 will not remove any bid for any reason.
16. As of 11/24/24 the Department Of Transportation has made a revision to the MV-6. Tax must be paid on all salvage vehicle sales. Tax will be charged for all salvage vehicle sales. This will be added to your bill of sale at pickup.
17. Buyers are not permitted to have a locksmith make keys at time of pickup. All vehicles are sold as is and must be towed off the property and the immediate surrounding area.
18. Effective 3/1/25 a \$75.00 fee will be charged to any buyer who needs any assistance loading a trailer at pickup

19. As a gesture of goodwill. A1 towing Auctions has chosen to update the terms and conditions. The following will apply effective immediately. All buyers will be allowed one chance to reinstate a blocked buyer account. A buyer must reach out once blocked and will be charged a 150.00 reinstatement fee. The fee must be paid in cash. This is a one-time gesture with absolutely no exceptions.

20. Effective September 1, 2025. There will be a \$5.00 per page fee for any duplicate forms needed.

21. Effective January 12,2026. Buyers you will only be granted one week after the end of an auction for a pickup extension.

PREVIEWING TERMS:

1. **1. You must be an approved buyer and over the age of 21.**
2. **2. You must be escorted by an employee**
3. **3. You must know which vehicles you want to see prior to heading out and limited to 5 at time.**
4. **4. No bags of any kind allowed while previewing**
5. **5. No tools/ No laying under the vehicles**
6. **6. Proper attire is required, no offensive clothing, no open shoes (crocs, flip flops, slippers).**
7. **7. You must wear safety vest provided while in the yard.**
8. **8. No pictures**
9. **9. No road test or moving of the vehicle for any reason. You may start the vehicles only**
10. **10. You may preview Tuesday from 9- 3 and Wednesday from 9-12 only no exceptions.**
11. **11. By agreeing to these terms you understand also you are going in to a salvage yard and hold A1 towing Ross Body and Frame harmless of any injuries that may occur.**
